- Reclamation from forest, from wetland, from "bad lands" like in Italy
- For us it is important that they are reclaimed for agriculture.
- Following our initiative of describing agricultural landscapes in Europe, we shall always stick to our landscape classification from the EUCALAND project.

- During our meeting and also as basis for the later article, we can start from the very beginning, saying what is reclamation of land, than define the different types of land reclamation and divide according to its use like we did with "terraced landscapes" at our Spain meeting.

  - Education, Training and Awareness-Raising
     Outstanding initiatives related to education, training and awareness-raising in the field of
     tangible and/or intangible cultural heritage in any of the above-mentioned areas, to
     promote and/or to contribute to the sustainable development of the environment.
