Add 2: Information German tax authorities: How to prove members' participation

Add 3: Member fees, members' exclusions – anonymized*

- There are several members which are delayed in paying their member fees.
- They have received one reminder per year.

- Nevertheless we prefer to write personal emails to the persons concerned.

- Further member / invoice matters anonymized*
 - There are some further membership issues which have been treated after the board meeting.
 - AK will check to whom the invoice for the Slovenian Academy of Science (MSH) was sent.
 - For Nibio: Only SE on the invoice, not also Wendy.
 - AK, BG: Also check WSL and the other invoices, where we have several active persons.
 - HR will pay last time as institutional member and then will change membership towards a personal one.
 - As we discussed already, now we really have to make an effort in getting new members.
 Especially when we lose again some.

Add 4: PECSRL – Eucaland session
